4. A copy of a passing health inspection dated on or after February 1, 2008 must be submitted along with your 2008 Summer Festival Food Sanitation Certificate by **June 2, 2008.**
5. Onesti Entertainment will provide one 10'x20' booth and one hand-washing station per booth, as well as assume responsibility for the City of Chicago Food Vendor application fee.
6. Onesti Entertainment is responsible for the placement of all booths.
7. All food vendors are required to have fire extinguishers in working order at their booth.
8. Vendors are to supply their own tables and chairs and tables must be covered in clean plastic.
9. Onesti Entertainment **MUST** approve food items, portion size and price. Please keep your portion sizes small and your prices low (typically between \$3.00-\$5.00) in order to encourage customers to purchase from multiple vendors. No food vendor will be allowed to serve beverages at any time.

10. If you need to rent equipment or purchase propane, you may do so at your expense through any vendor of your choice or through Classic Party Rental at the Onesti Entertainment discounted rate. To order equipment, please call Paul Hanlon at Classic Party Rental (708-485-8010), and tell him you are ordering through Onesti Entertainment for the Taylor Street Festa Italiana. It is your responsibility to receive your rental equipment from the driver, and return it to the driver. The time and date of delivery will be provided as soon as it is available. You are responsible for paying for any cleaning and/or replacement charges.
11. All food service equipment must be of professional quality.
12. Proper food service sanitation rules should be followed at all times. (1 person in the booth must be certified in outdoor food festival sanitation).
13. There will be **NO** washing of pans/dishes/utensils etc. in the booth. Have an adequate supply for between trips into your restaurant.
14. All food vendors are required to carry a stem thermometer.
15. Food vendors are asked to represent their businesses in a decorative and professional manner.
16. All employees of your booth are to conduct themselves in a professional and courteous manner at all times.
17. All food vendors must be in clothing that identify their business (i.e.: T-shirts, caps, aprons, etc.).
18. Vendors must provide their own garbage cans within their booths, and are responsible for disposing of their garbage in the dumpster provided.
19. Onesti Entertainment will issue employees and entertainers a limited number of \$1.00 food vouchers which are redeemable at food vendor booths. OEC will reimburse all food vendors after the fest for \$0.50 of each \$1.00 food voucher. Vendors are welcome to use the vouchers redeemed at their booth in order to purchase food and drinks from other booths at the festival.
